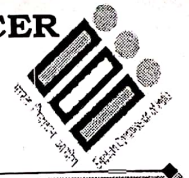

Subject: District Development Election-2020- Shifting of Polling Station because of Cease fire Violation from across the LOC-regarding.

ORDER

Whereas, the election for the 4th Phase of DDC Constituency (NSSB & Sathra) was scheduled to be held on 07-12-2020.

Whereas, Polling Station namely **08-MS Mandhar Jattan (Pyt. Mandhar) and 29-PS Sokar (Pyt. Darabagyal)** was located across the LOC fencing and is in the range of firing and shelling from across the border.

Whereas, above mentioned Polling Station was directly targeted from across the border in violation to ceasefire on intervening night of 5th of December-2020 and also in the morning of 6th Decemeber-2020

Whereas, report from District Police has also been received wherein it was mentioned that these Polling Stations/Area may be targeted again to disrupt the Poll process.

Therefore, in respect of the above mentioned facts and for the safety of the general masses of the area and of Poll Staff as well as for smooth conduct of the Election Process, the Polling Station namely a) **08-MS Mandhar Jattan is hereby shifted at Panchayat Ghar Mandhar** and b) **29-PS Sokar (falling in Pyt. Darabagyal) is shifted at GMS Darabagyal.**
