Subject: DDC/Pyt. By Election-2020- Repolling at 1) MS Bhunigam, 2) PS Kundan, 3) Tourist Hut Poshana and 4) PS Hill – notification thereon-regarding.

Whereas, repoll (DDC election) is ordered in four of the polling stations of Poshana village viz. MS Bhunigam, PS Kundan, Tourist Hut Poshana and PS Hill of the Bufliaz DDC constituency on 19th Dec, 2020 from 7Am to 2PM along with the 8th phase of the ongoing DDC elections in the district vide SEC order no. SEC/Pyt/2020/12 dt 12-12-2020.

Whereas, SEC has ordered that DPEO shall ensure that wide publicity is given to the re-poll as well as the exact locations of polling station is made known amongst all the stake holders, including the concerned electors generally and particularly in the areas where the inhabitants of Poshana generally migrates during winters/this period.

Whereas, one report was sought from Tehsildar Surankote regarding conduct of election in village Poshana. Tehsildar Surankote along with BDO Bufliaz reported that at present snow accumulation is around 6-8 inches in the area and if the weather remain clear for a period of one week then elections may be conducted at existing polling station in Poshana itself as the snow will clear further by then

Whereas, as per the weather advisory, weather is expected to remain sunny/clear for this whole week and therefore elections may be conducted at their existing locations in Poshana village itself. Moreover, villagers/voters are already familiar with these polling stations.

Accordingly, it is hereby ordered that re-poll will be done with polling station as follows,
