Subject Sanction of Ex-gratia compensation of Deceased / Permanent Disabled persons / houses damaged / loss of live stock due to POK Shelling during 2020-21.

ORDER No: DCP/Rel/07 of 2020-21

DATE: 14 -01-2021

Whereas, concerned Tehsildars have submitted the relief cases of deceased persons, Permanent Disabled persons / houses damaged and Livestock Loss due to POK Shelling during ceasefire violations across the LOC for payment of Ex-gratia relief in favour of sufferers under SRE.

Whereas, the relief cases have been placed before the SRE committee held on 12/01/2021 and the committee has approved the relief cases for payment of Ex-gratia relief to the sufferers.

Whereas, as desired by the Divisional Commissioner Jammu vide letter No. 301/793/V/2175-81 dated:- 30-12-2017 that pay the compensation for housing damages / Losses, Crop losses or loss of live stock relief for stay at relief camps and displacement etc. at the rates equal to NDRF/SDRF.

Whereas, as desired by the Divisional Commissioner Jammu vide letter No. 301/893/Relief/491-97 dated 28-06-2018 that pay the Compensation @ Rs. 50000/- per loss of milch animal against the existing rate of Rs. 30000/- per animal.

Hence, sanction is hereby accorded to the grant of Ex-gratia relief amounting to **Rs. 1719500/- (Rupees Seventeen Lacs Nineteen Thousand Five Hundred only/-)** in favour of Noks of deceased / Permanent Disabled persons / Private Property damaged / loss of live-stock due to POK Shelling during ceasefire violations across the LOC in the year 2020-21 as per detail given in annexure "A".

The expenditure on this account shall be debit-able **Major Head 2055-Police (SRE), Minor Head 117- Internal Security, Detail Head 032-Relief and Rehabilitation.**
