Subject: - Restrictions for Covid Containment- reg.

Ref: - (i) Government Order No: 21-JK (DMRRR) of 2021 dated: 18-04-2021.
(ii) Government Order No. 22-JK(DMRRR) of 2021 dated: 20-04-2021.

ORDER

Whereas, Department of Disaster Management, Relief, Rehabilitation and Reconstruction, J&K has issued fresh guidelines vide Order Nos. mentioned in reference above wherein some more restrictions have been imposed in view of prevailing trend of rise in daily report of COVID-19 cases in J&K. These are reproduced as under: -

“Public transport (metadoors/buses/mini-buses etc) in the District shall be permitted to ply only at 50% of its authorized seating capacity. The Sr. Superintendent of Police, Poonch shall ensure compliance to this effect”.

“The ceiling on number of people permitted to attend gatherings/ functions shall be 20 in case of funerals; 50 for all kinds of gatherings in indoor venues and 100 for all kinds of gatherings at outdoor venues”.

Now, therefore, I, **Inder Jeet**, KAS, District Magistrate, Poonch in exercise of powers vested in me u/s 34 Disaster Management Act, 2005 and section 144 CrPC do, hereby, order that: -

- a) The fine for violations to Order No: DMP/PA/32-41 dated: 02-04-2021 and Order No: DMP/PA/310-38 dated: 13-04-2021 shall now be Rs.200/- instead of Rs.100/-;
- b) The ceiling on number of people permitted to attend gatherings/ functions shall be 20 in case of funerals; 50 for all kinds of gatherings in indoor venues and 100 for all kinds of gatherings at outdoor venues. In case of violations, a fine of Rs.2000/- with additional Rs.100/- per person above ceiling shall be imposed.
- c) Public transport (metadoors/buses/mini-buses etc) in the District shall be permitted to ply only at 50% of its authorized seating capacity. The Sr. Superintendent of Police, Poonch shall ensure


compliance to this effect. In case of violations, a fine of Rs.200/- per person above the ceiling shall be imposed.

This order shall come into force with immediate effect on 21st of April 2021 and shall remain in force till further order.

In view of the emergent nature of the order, it is being passed ex-parte and addressed to the public in general. It shall be circulated in print, electronic, social media for information of all concerned.

Any violation of this order shall invite action as per the provisions of section 188 of the IPC and other legal provisions as applicable.
