Subject: - **Measures to prevent the spread of Corona virus – declaration of micro-containment zone thereof.**

ORDER

Whereas, in view of emerging situation due to Covid-19, the State Executive Committee of Department of Disaster Management, Relief, Rehabilitation and Reconstruction vide Govt. Order no. 27 -JK(DMRRR) of 2021 Dated:- 02-05-2021, has empowered District Magistrates to take local preventive measures for containment and breaking the chain of COVID-19 transmission; And

whereas, Tehsildar Surankote vide communication NO: N/Skt/86 Dated:-06-05-2021 and Tehsildar Haveli vide communication NO: 190TH/OQ/ dated: 06-05-2021 have requested to declare following areas as micro-containment zones since considerable number of corona positive cases have been reported from these areas.

Whereas, in order to check further transmission and to break the chain of COVID-19 infection in the area and after going through the communication received from Tehsildar Surankote/Tehsildar Haveli, I am of the considered opinion that it has become imperative to

take further stringent precautionary measures viz declaring these areas as Microcontainment zones.

Now, therefore, in view of the above and for the safety and well-being of general public, **I, Inder Jeet, KAS, District Magistrate, Poonch** in exercise of powers vested in me under section 144 CrPC, section 34 of the Disaster Management Act 2005 and section 3 of Epidemics Diseases Act, 1897 do hereby order as follows: -

1. *That the areas mentioned above are declared as Microcontainment zones.*
2. *That these areas shall be under strict lockdown and type perimeter control except for essential needs.*
3. *That there shall be no inward/outward movement of any person from these areas except in case of Medical emergencies and essential needs.*
4. *That it shall be mandatory for the persons residing in these areas to get themselves tested and any refusal in this regard shall invite action including filling of FIR under Disaster Management Act 2005 and Epidemics Diseases Act, 1897.*

It is Further ordered that:-

5. Tehsildar Surankote/ Haveli shall be the overall incharge of these containment zones for enforcement of SOPs.
6. Sh. Tarif Hussain Shah ,Naib Tehsildar Surankote (9107555786) shall be the Administrator for containment Zone, W.NO 8 & 10 Surankote.
7. Sh. Jatinder Raina Master GMS Plera,(9797693144) shall be the Administrator for containmment zone of W. No 1 Mohalla Qazi Mohra.
8. Chief Executive Officer MC Poonch/ EO Surankote shall ensure sufficient fumigation/Sanitization of these areas.
9. Tehsildar Haveli/ Surankote with BMO/SHO and Administrators concerned shall ensure 100% screening/Testing and vaccination of all eligible residents of these areas as well as download and use of Aroyga Setu App.
10. Block Medical Surankote/Mandi shall deploy sufficient staff for sampling and survillience within these designated areas.
11. The Distric Control Room shall monitor implementation of these instructions and shall submit the information to the undersigned on daily basis at 4:00 PM.
12. The Administrators shall ensure the availability of basic facilities including food grains, LPG, medicines in Containment Zones through concerning departments.




The contact number of COVID-19 Control No. 01965-222012, 01965-222079 (Medical Emergency) shall be widely circulated among the population so that the information with regard to any suspect shall be shared by locals with the authorities. The inhabitants can also call on aforesaid contact numbers in case of any medical emergency.

In view of the emergent nature of the order, it is being passed ex-parte and addressed to the public at large. It shall be circulated in print, electronic, social media for information of all concerned.

Any violation of this order shall invite action as per the provisions of section 188 of the IPC and other legal provisions as applicable.
