Consequent upon Govt. order No. 442/HIME of 2019 dated 24-4-2019, and guidelines for opening of Pradhan Mantri Bhartiya Jan Aushadi Kendras in J&K state, Applications are invited from eligible registered pharmacist to work on profit sharing basis in one additional Pradhan Mantri Bhartiya Jan Aushadi Kendras to be setup by the department on format given as Annexure "A" ( PMBJKs DH Poonch ). Application forms complete in all respect should be submitted to this office personally on or before 01-6-2021.

### Terms and Conditions & Selection Criteria:-

1. The Selected candidates shall have to work in Pradhan Mantri Bhartiya Jan Aushadi Kendras on profit sharing basis.
2. The selected candidates have to work for a period of 3 years on performance basis.
3. The selected candidates shall not confirm any right for his or her permanent absorption/ regularization in the department.
4. The candidates can be terminated by the committee at any time without surviving any prior notice in case of unsatisfactory performance or violation of agreement.
