Subject: - Restrictions for COVID Containment – reg.

ORDER NO. 24 of 2021

Date: 13-06-2021

Whereas, State Executive Committee Department of Disaster Management Relief, Rehabilitation and Reconstruction vide Order No: 38-JK(DMRRR) of 2021 dated: 13-06-2021 after a detailed review was conducted by Worthy Chief Secretary J&K with senior Officers, has granted certain relaxations to a few activities in eight Districts of the UT including Poonch on account of significant improvement shown in parameters namely;

- Total weekly new cases (per million).
- Total positivity rate.
- Bed occupancy.
- Case fatality rate.
- Vaccination coverage of targeted population.

Whereas, detailed instructions have been issued separately vide this office Order No.16 of 2021 Dated: 30-05-2021 and accordingly roster for opening shops/establishments in the district was issued vide Order No.21 of 2021 Dated: 06-06-2021. However, in view of the fresh relaxations, it becomes imperative to issue roster with these relaxations incorporated in it.

Therefore, I, Inder Jeet, KAS, District Magistrate, Poonch in exercise of powers vested in me U/S 34 of Disaster Management Act, 2005 and section 144 of CrPC do, hereby, order that the shops/establishments shall be allowed to open/operate within the Limits of District Poonch as per schedule given below:-

S.No	Item	Days	Timing
1	Chemist Shops/ Testing Labs and Health Clinics/ all medical and optical facilities.	Daily basis	
2	Milk & Milk Product Shops, Sweet shops, Vegetable & Fruit Shops, Bakeries, Eateries and Chicken/ Mutton Shops/ Street Vendors.	Daily basis	Upto 1:00 pm
3	Stand alone Outdoor Shops, Outdoor Bazaars and Outdoor Shopping Complexes including Barbers, Saloons and Parlours.	All days except Saturday and Sunday.	11:00 am to 7:00 pm



All Government and Private Offices can function without any restrictions subject to strict adherence to COVID appropriate behavior.

Any shop/establishment not mentioned above shall operate on Monday to Friday from 11:00 am to 7:00 pm.


However, these shops/establishments on their days of opening shall be allowed to operate with the conditions that SOPs related to COVID-19 including maintaining of social distance, wearing of face masks and placing of sanitizers at the entrance shall be strictly followed.

This order shall come into force with effect from 14th of June, 2021 and shall remain in force till further order.

In view of the emergent nature of the order, it is being passed ex-parte and addressed to the public in general. It shall be circulated in print, electronic, social media for information of all concerned.

Any violation of this order shall invite action as per the provisions of section 188 of the IPC and other legal provisions as applicable. Sr. Superintendent of Police, Poonch shall strictly enforce compliance to this order.
