

Order No: REV/ER 08 of 2015 dated; 10-01-2015 held on **27-08-2021** under the Chairmanship of Addl. District Development Commissioner (Chairman SDRF) Poonch and approved 28 cases for providing of relief as per SDRF norms.

Hence, Sanction is hereby accorded to the grant of relief amounting to **Rs. 2174500/- (Rupees Twenty One Lacs Seventy Four Thousand and Five Hundred Only)** on account of Natural Calamities as admissible under State/National Disaster Response Fund (SDRF/NDRF) norms vide Govt. of India No. (MHA letter No: (Period 2015-2020, MHA letter No. 32-7/2014-NDM-I dated 8th April 2015) in favour of the sufferers whose details shown against each as per **Annexure "A"**.


