Subject: Sanction of Ex-gratia Assistance to the NOKs of deceased by Covid-19 through SDRF during the year 2020 and 2021.

Whereas, the Sub-Divisional Magistrate Mendhar / Assistant Commissioner (Rev) Poonch have submitted the relief cases of NOKs of deceased due to COVID-19 for payment of Ex-gratia Assistance through SDRF.


Whereas, these cases have been verified by the committee constituted by the undersigned vide Order No: DCP/PA/7176-86 dated: 01-12-2021 as per Govt. Order No: 83-JK(DMRRR) of 2021 dated: 29-11-2021 and the committee held its meeting on **10-12-2021** under the Chairmanship of Additional Deputy Commissioner (Chairman CDAC) Poonch and approved **14 cases** for providing of Ex-gratia Assistance to the NOKs of deceased by COVID-19.

Hence, Sanction is hereby accorded to the grant of Ex-gratia Assistance amounting to **Rs. 700000/- (Rupees Seven Lacs Only)** (@ 50,000/- per death case) on account of death cases due to Covid-19 as per the guidelines issued by National Disaster Management Authority Govt. of India vide No: 16/11/20 21-RR dated: 11th September 2021 in compliance to the Hon'ble Supreme Court Order dated:30-06-2021 in WP(Civil) No: 539 and WP(Civil) 554 of 2021 and guidelines issued by the State Executive Committee, Department of Disaster Management Relief Rehabilitation and Reconstruction vide Govt. Order No: 83-JK(DMRRR) of 2021 dated: 29-11-2021, in favour of the beneficiaries (NOKs of deceased by COVID-19) whose details shown against each as per **Annexure "A"**.

The expenditure on this account shall be debit-able to **Major Head "2245- Relief on account of Natural Calamity, Minor Head 101-Transfer to Reserve Funds Deposit Accounts SDRF, 0099-General, 1076-SDRF, 032- Relief and Rehabilitation"**.


