SHOP-TENTS FOR SHRI AMARNATHJI YATRA 2020 VIA BALTAL ROUTE.**

- Applications in duplicate on prescribed form are invited from Individuals/ Agencies for grant of permission for pitching of BOARDING TENTS/ SHOP TENTS at various locations enroute to Holy Cave via Baltal Route, viz. BALTAL BASE CAMP/ BETWEEN BALTAL BASE CAMP & DOMEL ACCESS CONTROL GATE (UPTO 300 METRS BEFORE THE ACCESS CONTROL GATE)/ RAILPATHRI/ BRARIMARG/ SANGAM AND HOLY CAVE for Yatra 2020. The Application Forms shall be available (Free of cost) from 5<sup>th</sup> February, 2020 to 5<sup>th</sup> March 2020 (upto 4:00pm) in the offices of the Deputy Commissioner, Ganderbal and Sub Divisional Magistrate Kangan respectively.
- In case the applicant intends to apply for more than one location, he would be required to submit one application form in duplicate indicating the preference thereof.
- The permission for pitching of Boarding/ Shop Tents shall be granted by the Deputy Commissioner Ganderbal through Draw of Lots in case the applications received are more than the target fixed.
- The permission holder shall be required to pitch tents of the following size/specifications only.  
**Size**
  - 12' x 14' for BOARDING TENT
  - 8' x 12' for SHOP TENT**Specifications**
  - Double-Fly Untorn canvas or cotton tent.
  - Inner Fly -100% waterproof canvas or cotton of atleast 500 GSM with lining.
  - Outer Fly -100% waterproof canvas or cotton.
  - Canvas or Cotton should be rat proof and fire retardant.
  - With ground shell, complete with metal/wooden poles and pegs.
  - Weather hoods on both sides for protection against rain/snow.
  - Good quality bedding in case of boarding tents.
- No individual/family shall be issued permission to pitch more than one tent in the particular Yatra Camp area.
- Only one person (permission holder) who will be issued identity card shall be allowed to enter the Yatra area for managing the affairs of Tent.
- The filled-in application form alongwith documents detailed therein shall be submitted at the following office before the scheduled date and time:  
**Office of Deputy Commissioner Ganderbal, Mini secretariat Complex Duderhama Ganderbal from 15-02-2020 to 15-03-2020 (upto 4:00 pm)**
- No application form shall be entertained after the prescribed date/time.
- Permission shall be issued subject to production of the agreement to abide by the prescribed terms and conditions laid by the District Administration/SASB and clearance from the police department.
