Subject: Imposition of complete restrictions (Night Curfew) under Section 144 CrPc in district Ganderbal from 10:00 p.m to 05:00 a.m.
Reference i. Government Order No. 98-JK (DMRRR) of 2020 dated:- 30/12/2020

O R D E R

Whereas, Government of India vide its Order No.40-3/2020-DM-I(A) dated:- 28/12/2020 has issued new guidelines/instructions on lockdown which will be in force up to 31.01.2021;and

Whereas, Government of Jammu & Kashmir vide order under reference has ordered that guidelines/ instruction issued vide Order No.91 and 92-JK-(DMRRR) of 2020 dated:-29/11/2020 in the Union Territory of Jammu & Kashmir shall continue to remain in force up to 31.01.2021; and

Whereas, Government of Jammu & Kashmir vide Order mentioned supra has ordered inter-alia the complete restrictions on the movement of individuals for all non-essential activities between 10:00 pm to 05: 00 a.m,

Therefore, in view of above, I Shafqat Iqbal (KAS), District Magistrate Ganderbal, in exercise of powers vested in me under Section 144 CrPc, do hereby order the imposition of complete restrictions on the movement of individuals for all non-essential activities in district Ganderbal from 10:00 pm to 05:00 am (Night Curfew) till 31st January, 2021.

The Police authorities /Executive Magistrates /Incident Commanders shall enforce the order in their respective areas of jurisdiction forthwith.

Any violation of this order by any person shall invite punitive action under the relevant law(s).
