NOTICE INVITING APPLICATIONS FOR PITCHING OF BOARDING TENTS/SHOP TENTS FOR SHRI AMARNATHJI YATRA 2021 VIA BALTAL ROUTE


1. Applications in duplicate on prescribed form are invited from Individuals / Agencies for grant of permission for pitching of BOARDING TENTS / SHOP TENTS at various locations enroute to Holy Cave via Baltal Route, viz Baltal Base Camp / Between Baltal Base & Domail Access Control Gate (upto 300 Mtrs before the Access Control Gate) / Railpathri / Brarimarg / Sangam and Holy Cave for Yatra 2021. The application forms shall be available (Free of Cost) from 10th February, 2021 to 10th March, 2021 (upto 04:00 PM) in the offices of the Deputy Commissioner, Ganderbal and Sub Divisional Magistrate, Kangan respectively.
2. In case the applicant intends to apply for more than one location, he would be required to submit one application form in duplicate indicating the preference thereof.
3. The permission for pitching of Boarding/Shop tents shall be granted by the Deputy Commissioner Ganderbal through Draw of Lots in case the applications received are more than the target fixed.
4. The permission holders shall be required to pitch tent of the following size/specifications only.

SIZE

- a. 12' x 14' Boarding tent
- b. 8' x 12' shop tent

SPECIFICATIONS

- a. Double-Fly Untorn Canvas or cotton tent.
 - b. Inner Fly-100% waterproof canvas or cotton at least 500 GSM with lining.
 - c. Outer Fly-100% waterproof canvas or cotton.
 - d. Canvas or cotton should be rat proof and fire retardant.
 - e. Ground shell, complete with metal/wooden poles and pegs.
 - f. Weather hoods on both sides for protection against rain / snow.
 - g. Good quality bedding in case of boarding tents.
5. No individual/family shall be issued permission to pitch more than one tent in the particular yatra camp area.
 6. Only one person (permission holder) who will be issued identity card shall be allowed to enter the yatra area for managing the affairs of tent.
 7. The filled-in application form along with documents detailed therein shall be submitted in the office of Deputy Commissioner, Mini Secretariat Complex Duderhama Ganderbal from 10th February, 2021 to 10th March, 2021 (upto 04:00 PM)
 8. No application form shall be entertained after the prescribed date / time.
 9. Permission shall be issued subject to production of the agreement to abide by the prescribed terms and conditions, as laid by the District Administration / SASB and clearance from the police department.
