Whereas, the Vice President Megha Engineering and Infrastructures Ltd. approached this office through letter dated: 05.11.2020 pleading therein that they intent to construct Explosive Magazine for storing the Explosives and detonators required for blasting in the aforementioned Tunnels; and

Whereas, the Offg.Executive Director (P),RO-Srinagar, NHIDCL vide his letter No. NHIDCL/PMU-SMG/ZOJILA/2020-21/83 dated: 18.02.2021 has recommended that permission may be granted to M/s MEIL for constructing the explosive magazine for the above mentioned project, as they have been engaged by them; and

Whereas, for the aforesaid purpose they have identified a piece of land measuring 3 Kanals falling under survey No. 114 min in estate Sonamarg and have accordingly requested for grant of “No objection Certificate” in their favour; and

Whereas, a report along with records in the matter has been obtained from Tehsildar Gund , who has reported that the proposed site is far away from the residential area.

As such, before proceeding ahead in the matter, and as laid down thereunder in section 103 of Explosives Rules 2008, the General Public is hereby informed by virtue of this instant notice, that if anybody is having any objection with regard to construction of the Explosive Magazine at the proposed site, he /she may convey the same to this office within 30 days time from the date of publishing of this notice. No objection after the stipulated time shall be entertained.
