**Subject: Restrictions for COVID containment - regarding.**

Reference: i. Government Order No 21-JK (DMRRR) of 2021 dated 18-04-2021.  
ii. Government Order No 23-JK (DMRRR) of 2021 dated 24-04-2021.

**ORDER**

Whereas, Government of Jammu and Kashmir vide Order No 21-JK (DMRRR) of 2021 dated 18-04-2021 and Order No. 23-JK (DMRRR) of 2021 dated 24-04-2021 has issued guidelines / instructions on restrictions for COVID containment; and

Whereas, epidemic diseases act, 1897 and Disaster Management Act, 2005 also empower the undersigned to issue certain directions for safety and preventing any harm to human life.

Whereas, an overall assessment of the situation pertaining to the spread of COVID-19 and prevailing trend of rise in the daily reported cases of infection in District Ganderbal; and

Whereas, in view of the situation emerging due to COVID-19 in District Ganderbal, there is sufficient ground for proceeding under section 144 of CrPC for immediate prevention or speedy remedy is desirable to prevent danger to human life, health or safety; and

Now, therefore, in view of above, I, **Krittika Jyotsna (IAS), District Magistrate Ganderbal** in exercise of powers vested in me under section 144 CrPC read with relevant provisions under the Epidemic Diseases Act, 1897 and the Disaster Management Act, 2005 do hereby order the following:

1. **Complete Corona Curfew shall be imposed in the District Ganderbal w.e.f. 08:00 pm on 24-04-2021 (Saturday) till 06:00 am on 26-04-2021 (Monday).**

*(There will be no bar on movement of officers / officials related with COVID-19 vaccination and testing, their ID cards shall be treated as curfew pass)*

2. Essential / emergency services / movement / work and scheduled marriages up to permissible gathering norms shall remain exempted, subject to productions of wedding cards / ID cards or the curfew passes issued by the District Magistrate.

3. The technical training institutions falling under the department of Skill development / Technical Education shall also remain closed for on-campus / in-person education till 15-05-2021. Online education shall be the mode of teaching.
4. During the closure of educational institutions (Schools / Colleges / Universities / Technical education etc), attendance of staff in person shall be restricted to 50 percent only. All heads of the institutions shall devise rosters to ensure this, as per the directions to be issued by School / Higher Education Department in this regard. Such staff of educational institutions as are needed by the District Disaster Management Authorities / undersigned for official duties shall not be exempted from duties on account of this order.
5. The ceiling on the number of people permitted to attend gatherings / functions shall be 20 in case of funerals, 50 for all kinds of gatherings at indoor venues and 100 for all kind of gatherings at outdoor venues.

Since it is not possible to serve this order individual, it shall be circulated in print, electronic and social media for information of all concerned. Any violation of this order by any person shall invite punitive action under the relevant law(s).

Police / Executive Magistrates shall enforce the order in their respective areas of jurisdiction.
