**Subject: Containment & Management of COVID-19(Corona Virus) –Declaration of Micro- Containment Zones thereof.**

**ORDER**

Whereas, 3 fresh COVID-19 positive cases from **Ragandar Mohalla Nunnar** Tehsil **Ganderbal** have been reported w.e.f 7/10/2021 from SKIMS/CD Hospital Srinagar/DH Ganderbal/Rapid Antigen Testing; and

Whereas, it is possible that the said positive COVID-19 cases might have contacted with many persons belonging to **Ragandar Mohalla Nunnar** Tehsil **Ganderbal** as such the locals of the village have become susceptible of COVID -19; and

Whereas, it is felt expedient to break further transmission of COVID-19 and has become imperative to take stringent precautionary measures by declaration of **Ragandar Mohalla Nunnar** Tehsil **Ganderbal** as **micro-Containment Zone**.

Therefore, in view of above, I **Krittika Jyotsna (IAS)**, District **Magistrate** Ganderbal, in exercise of powers vested in me under **the Epidemic Diseases Act, 1897, the Disaster Management Act, 2005 and Section 144 CrPc**, do hereby order as follows: -

- a. That **Ragandar Mohalla Nunnar** Tehsil **Ganderbal** is declared as **Micro Containment Zone**.
- b. That there shall be no inward or outward movement of any Person from the **micro containment Zone** and people shall stay indoors as there will be complete restrictions in **Ragandar Mohalla Nunnar** Tehsil **Ganderbal** and they shall not allow relatives/visitors to visit their homes.
- c. That **Mr. Dr. Rouf** contact No:- **7889309072** He shall be the **Administrator of Micro Containment Zone**. He shall coordinate with all line departments to ensure the availability of all basic facilities including Food grains/LPG/Medicines etc in the **Micro Containment Zone**.
