**ORDER No. 6-DDCR Of 2020
DATED:- 22-03-2020**

In continuation to this office orders mentioned under references issued from time to time for containment and management of Corona(COVID-19), **more preventive measures/steps** are required to be taken for effectively checking the spread of the virus.

Accordingly **I, District Magistrate, Rajouri**, by virtue of powers vested in me under the provisions of **Disaster Management Act, 2005** and Section 144 of IPC do hereby order that in addition to the measures/steps taken earlier, following shall also remained closed/suspended in territorial jurisdiction of district Rajouri with immediate effect till 31st of March 2020.:

1. All business establishments.
2. All Public Transport.
3. Assembly of more than 3 persons and Public movement in the territorial jurisdiction of District Rajouri.
4. All religious Prayers/Congregations /Marriages/other Events.

However, these restrictions shall not apply to the following:

1. Health & Medical Services including Chemist shops
2. Services rendered by FCI & J&K Food Civil Supplies & Consumers Affairs including LPG & Petroleum products.
3. Groceries, Milk & Milk products, Fruit, Vegetable, fodder and feed supplies
4. Power & Water Supplies
5. Services rendered by Urban Local Bodies – Municipal & Sanitation.
6. Telecommunication, Newspaper and Post Offices
7. Banks and ATMs
8. Fire and Emergency Services.
9. Vehicles transporting above mentioned services (exempted ones) shall be allowed to enter district Rajouri at Sunderbani only after obtaining necessary permit/pass from ADM Sunderbani. ADM shall make necessary arrangement for this.

This order shall come into force with immediate effect & any violation thereof shall invite punitive action under relevant provision of the law under **National Disaster Management Act, 2005**.
