**Subject: Restrictions for COVID-19 containment in District Rajouri.**

**ORDER**

In continuation to this office order No. 50-DMR of 2021 dated 30.01.2021 issued under endorsement No. COVID-19/DMR/175-V/2021-22 dated 30.04.2021, by virtue of which restrictions were imposed with certain exemptions pertaining to essential services under section 34 of National Disaster Management Act, 2002 in District Rajouri.

It is clarified that "Corona Curfew" shall be imposed within municipal/urban local body limits of district Rajouri w.e.f 07:00 pm each Friday till 07:00 am each Monday.

However, the essential services i.e. Medicine shops, Testing Laboratories, Medical & Clinical establishments, Petrol Pumps will remain open during Corona Curfew from 07:00 AM to 07:00 PM.

Milk Shops/Dairy product shops, Bakery shops, Fruit & vegetable shops, Chicken & Mutton shops will remain open during Corona Curfew from 07:00 AM to 11:00 AM.

And Retail/wholesale licensed shops of Agriculture/Horticulture shops, Fair price shops of Ration, LPG Agencies, Kerosene Oil shops and Animal Fodder shops will remain open during Corona Curfew from 09:00 AM to 01:00 PM (except Sunday).

All the shopkeepers shall ensure that social distancing is maintained during this time slot and all the instructions issued by the District Administration from time to time are followed in letter and spirit.

All government works specially permitted & the vehicles engaged in transportation of construction material for vital government projects shall be exempted. The government offices, ATMs, Banks, Post Offices and Couriers shall also remain exempted.


The District Superintendent of Police, Rajouri shall implement this order in letter and spirit.
