ORDER

In continuation to Order No: DMR/COVID-19/614-28 dated 10.05.2021 and JC/DMR/2021-22/681-96 dated: 16.05.2021 in exercise of the powers conferred upon me u/s 144 of Cr.P.C, Section 34 of Disaster Management Act and section 2 & 3 of Epidemic Disease Act, 1897 **I, Rajesh Kumar Shavan, KAS District Magistrate, Rajouri** order as under:-

1. The Corona Curfew imposed in the District earlier up to 24.05.2021, is hereby extended further by seven more days till 07:00 AM on Monday 31.05.2021
2. The curfew will be strict except for a few essential services as notified in the previous order dated 10.05.2021 & 16.05.2021.
3. Gathering permissible for marriages and other religious functions shall continue to be restricted to only 25 in number.
4. Other terms and conditions, as laid down in the order No. DMR/COVID/19/614-28 dated: 10.05.2021 & JC/DMR/2021-22/681-96 dated 16.05.2021 shall remain the same.
