In continuation to this office Order No. DMR/2021-22/JC/PA/261-300 Dated 20.06.2021 and Order No. DCR/2021-22/PA/193-209 Dated 22.05.2021 regarding Restrictions for COVID Containment & Management regarding and in order to prevent the spread of COVID-19 in the district, I, **Rajesh Kumar Shavan, KAS, District Magistrate, Rajouri** in exercise of the powers conferred upon me U/S 144 Cr. P. C., Section 34 of Disaster Management Act and Section 2 & 3 of Epidemic Disease Act, 1987, order as under:-

1. The restrictions imposed vide this office Order No. DMR/2021-22/JC/PA/261-300 Dated 20.06.2021 & Order No. DCR/2021-22/PA/193-209 Dated 22.05.2021 for opening of shops on odd even basis in the busy market places/shopping complexes in Urban areas as well as at Darhal, Koteranka, Budhal, Manjakote, Dhangri, Muradpur, Badhoon, Palma, Teryath shall continue, with **Night Curfew from 08.00 PM to 07.00 AM on daily basis and weakened curfew from Friday 08.00 PM till Monday 07.00 AM.**
2. The outdoor shops/bazaars at standalone places in Rural Areas shall open for **5 days only i.e. from Monday upto Friday.**
3. The Executive Magistrates, Police and other Officers deployed for COVID Management will ensure proper **COVID Appropriate behaviour** and shall book the defaulters under law.
4. The timings of the shops shall be from **08.00 Am to 06.00 PM.**
5. **Teachings in all the Institutions through online mode and Schools, Colleges, Universities, Technical Institutions shall continue.**
6. **Passengers/Travellers entering the District shall mandatorily undergo COVID-19 Rapid Antigen Test at Check Posts/Boundary of the district.**
