Reference: Government Order No. 02-JK (DMRRR) of 2022, dated 02.01.2022 issued by the State Executive Committee, Department of Disaster Management, Relief, Rehabilitation and Reconstruction.

ORDER NO. 02 DMR OF 2022

DATED: 05 -01-2022

Whereas, the State Executive Committee, Department of Disaster Management, Relief, Rehabilitation and Reconstruction, J&K vide Order No. mentioned under reference, has issued directions for complete restrictions on non-essential movement in the entire UT of J&K, from 9:00 PM to 6:00 AM, in view of surge in COVID-19 cases; and

Now therefore, consequent upon the above directions issued by the SEC, DMRRR, as well as in the interest of safety/wellbeing of the public at large and to break the chain of transmission, I **Vikas Kundal, IAS, District Magistrate Rajouri (Chairman District Disaster Management Authority)** in exercise of the powers conferred upon me under section 34 of National Disaster Management Act, 2005, do hereby order that:

“There will be complete restrictions on non-essential movement within the territorial jurisdiction of entire District Rajouri from 09:00 PM to 06:00 AM, on daily basis with immediate effect.”

Senior Superintendent of Police shall ensure the enforcement of the orders in letter and spirit.

Since, it is not possible to serve prior notice to this order, it is as **such being issued *ex-parte***. It shall be circulated in print, electronic and social media for information of all concerned.

Any violation of this order shall invite punitive action under **section 188 of the Indian Penal Code** and relevant provisions of the **Disaster Management Act, 2005**.

This order shall remain in force with effect from 05.01.2022, till further orders.
