MINUTES OF DTF MEETING

A meeting of District Task Force (South East) was held under the chairmanship of Deputy Commissioner / District Magistrate (South East) on 06/08/2014 at 4:00 PM in his chamber in which the following attended the meeting:

No representative of SDMC was present in the meeting to inform about the action taken on the decisions, concerning SDMC, of the last meeting.

1. Representative of DUSIB informed that he will ask the concerned E.E. to submit a report on the action taken on the decision of the meeting on 06.08.2014.

Action: DUSIB

2. DD (LM/SEZ), DDA submitted an ATR about successful programme carried out in Tamoor Nagar, also informing that program had to be rescheduled due to the concerned SHO handing over a letter dtd. 15.07.14 to their Kanungo asking for re-fixing of the demolition. Chairman conveyed his displeasure about the SHO writing a letter suggesting for postponing the demolition program as the same was already decided by DTF in consultation with DCP(South East) in meeting held on 06.08.2014.

Action: Delhi Police (South East)

was still to be removed after the demolition was carried out. Chairman DTF expressed his displeasure about non-removal of malba as this would hamper the follow through of water in the drain defeating the very purpose of demolition action. The Deputy Director (LM), DDA stated that the MCD did not provide any manpower and machinery for the demolition programme and as such the malba was not removed. Chairman DTF directed that MCD and DDA should jointly remove the malba from the site within 3 days, failing which the concerned field officials may be issued show cause notice.

Action: SDMC (Central Zone), DDA (LM)

4. PWD representatives brought to the Notice of the Chairman that lot of malba from unauthorized construction in the areas was being dumped around Nehru Stadium during the night. They informed that they had written to SDMC to stop illegal dumping of malba on road side but no action had been taken so far. ACP (HQ), Delhi Police stated that concerned SHO would take action against such illegal dumping of malba in case complaint is made to Delhi Police. PWD authorities were directed to send a detailed complaint to the concerned SHO through DCP(South East) for appropriate action in the matter.


Action: Delhi Police (South East), PWD (M-411 & 412)

5. There was no proposal from PWD and BDO(South / South East) for carrying out any demolition programme of encroachment on Govt. land. They were asked to bring any proposal for clearing the govt. land from encroachment in the next DTF meeting.

Action: PWD (M-411 & 412), BDO (South / South East)
