ORDER

Dated Shillong, the 14th October, 2020.

Whereas, Government of Meghalaya in exercise of powers conferred Under Section 2, 3 & 4 of the Epidemic Diseases Act, 1897 has constituted The Meghalaya Epidemic Diseases, COVID-19 Regulations, 2020 and Amendments thereof for Containment of outbreak of COVID-19,

And whereas, detection of positive COVID-19 cases/high-risk contacts **in the Flat of Shri Biswajit Das (tenant) in the Top Floor of Narayan Bhavan, Riat Laban** requires contact tracing, testing and isolation to be effected in the interest of health of general public to prevent against any possible spread of COVID-19,

Therefore, it is necessary to declare **the above mentioned flat as a micro-containment area so as to restrict unregulated entry and exit on the site;**


- No person shall be allowed to move into the containment area and inhabitants within this area shall not move out.
- All the inhabitants within the containment area shall strictly remain inside their home.
- The Incident Commander, Zone-II, Shillong shall supervise and monitor strict compliance of the order.

Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and I.P.C.

In view of the urgency of the matter, this Order has been made ex parte.
