Dated Shillong, the 1st May, 2021.

In pursuance to order of the Government of Meghalaya issued vide NO,POL.75/2020/PtI/91 dated 28th April, 2021 and No.Health.114/2020/46 dated 28th April 2021 and with a view to ensure that there is no spread of the virus at funeral gatherings, the following guidelines are to be followed at all funerals/cremation/last rites:-

1. Maximum number of persons permitted is 30 (thirty).
2. Social distancing of 2 metres/6 feet is to be strictly maintained.
3. Handshakes /body contact should be avoided as far as possible.
4. Hand sanitizers are to be provided to the attendees and should be used frequently.
5. Meals served to guests to be avoided.
6. Family and relatives should ensure that attendees do not stay for long.
7. At the residence/houses or burial/cremation ground, number of people should strictly adhere to 30 (thirty) at any point of time.
