1. All bidders are informed to refer to Annexure I of the Tender document for Block wise quantity (in Quintals), Block wise EMD (Earnest Money Deposit) and SD (Security Deposit) amount details as per previous year's transportation cost of DSD.
2. The Deputy Commissioner reserves the right to accept or reject any or all tender or tenders or to annul the tendering process at any stage.
3. Price bid for providing Transportation & Handling Services shall be quoted in Indian rupees per quintal basis. The rate shall be quoted separately for the Blocks in a district. There would be a single rate which bidder will quote on the electronic platform during auction process. This single rate would be valid for transportation of food grain through DSD Transporter to a particular Block in that district. The tenderer shall quote the rate for providing Transportation and Handling Services inclusive of duties and other Statutory levies payable by them and inclusive of GST.

4. The bid rates above upper ceiling rates will be rejected. Also, the Bid Rate below the Lower Floor Rate will be rejected and for the rejected blocks re-auction will be conducted. The Upper Ceiling Rate, as has been decided, will be Rs. 40 (Rupees Forty) Per Quintal and Lower Floor Rate is Rs 30 (Rupees Thirty) per quintal. The minimum Bid rate Tick size is TWENTY-FIVE paise per quintal and the maximum bid rate can be decreased by Rs 2.
5. In case of rescheduling of Reverse auction, no further time will be given to new tenderers to register.
6. Block wise auction for a district will be of 10 minutes with Two (2) extensions of 2 minutes each will be allowed. Please refer to Tender document "Invitation of Tenders providing Block wise Door-Step Delivery (Transportation & Handling) Services to the Fair Price Shops (FPS) located in Urban areas and Blocks of Jharkhand for detailed guidelines.
