Whereas Curfew under section 144 Cr.P.C was imposed by the undersigned vide endst. No. 5713-99 dated 23-3-2020 to prevent and contain spread of Corona Virus Disease. Subsequently vide endst no. 5804-74 dated 23.03.2020 and 5951-75 dated 24.03.2020, following services were exempted on the production of the identity card issued by their respective heads:-

6. Bathinda Terminal Indian Oil Corporation Limited, Jassi Chowk Bathinda.
7. Bathinda Terminal, BPCL, Jassi Chowk, Bathinda
8. Bathinda Terminal HPCL, Jassi Chowk, Bathinda
9. All doctors / employees of Health Department posted in the district for duty purpose
10. All the Veterinary Doctors for duty purpose and Veterinary Hospitals
11. AIIMS, Bathinda.
12. Bottling Plant BCL, Machana for the purpose of manufacturing of Sanitizer.
13. PSPCL/ PSTCL and Guru Gobind Singh Thermal Plant, Lehra Mohabbat
14. Staff of BSNL
15. Sanitation workers of Municipal Corporation, Bathinda
16. Cremation Ground Staff of all the cremation grounds of the district
17. ROs water staff of Municipal Corporation, Bathinda
18. Verka Milk Plant, Bathinda
19. Indian Oil Petrol Pump, Jassi Pau Wali Chowk
20. HPCL Petrol Pump, Phase II Model Town, Bathinda
21. Bathinda Service Station, Bathinda
22. Maur Service Station, Maur
23. Nursi Ram Aggarwal Filling Station, Rampura Phul
24. Guru Kashi Filling Station, Talwandi Sabo
25. Surjit HP Station Near HPCL, LPG Plant Raman
26. Highway Petro Care Centre Near HMEL Refinery, Ramsra

In addition to above-said services, following services are also exempted from the provisions of order dated 23-3-2020:-

1. Running of the Goods train and other essential services on the production of pass issued by Sh. Barjinder Singh, Inspection RPF Post, Bathinda.
2. Farmers engaged in potato digging, transportation and storage of potatoes.
3. Vehicles loaded with cattle/poultry/piggery feed, fodder, eggs.
4. All Electronic/Print Media persons on production of their Card.
5. Employees of the Water Supply and Sanitation department on production of Identity card.
6. Official/labour/truckers engaged in loading/unloading operation of special goods train duly authorized by DFSC, Bathinda

These institutions/ officers/ employees will follow the instructions / orders issued by Govt. of India/ Govt. of Punjab and undersigned regarding the Covid-19. Any violation of these instructions / orders is liable to criminal prosecution.
