In pursuance of selection of candidates by the Odisha Sub- Ordinate Staff Selection Commission communicated vide letter no.IIE-47/2016-549 ©/OSSSC Dt.19.12.2016 and IIE-57/2017-277©/OSSSC/Dt.19.03.2018 and letter no. 169©/OSSSC Dt.15.02.2018 & D.O. letter no. 174/SWCD Dt.19.09.2016 of Commissioner Cum Secretary, Women and Child Development Department, Odisha, Bhubaneswar the following candidates are provisionally appointed as Supervisor on Contractual basis in the consolidated pay of Rs. 16,880/-per month under PB-2. This is in accordance with Odisha Group-C & D post (Contractual Appointment Rules, 2013).During the period of contractual appointment she shall draw monthly remuneration as per G.A. Department Notification No. GAD-SC-Rules-0037-2017-19569/Gen Dt. 12.09.2017. Appointment is contractual initially to be guided by the Odisha Group-C & D (Contractual Appointment) Rules, 2013 notified vide G.A. Department Notification No. GAD-SC-Rules-0009-2013-32010/Gen Dt. 12.11.2013. The appointment is subject to final outcome of the OA Case no. 1266 ©/2017.

Their contractual services shall be renewed every year basing on their satisfactory performances. They can be regularized on completion of 6 years of continuous satisfactory service.

They are entitled for leave under the provision of the Odisha leave Rules, 1966.

Besides they shall be enrolled under New Pension Scheme contained under appointment made under Rule-9(1) of the said rule.

The appointment is purely temporary and can be terminated at any time without notice or assigning any reason thereof.

- 1- They should join the post latest by **30.04.2018** in the ICDS Projects as noted against each failing which their appointment stand automatically cancelled and they will not claim for any further appointment in this establishment.
- 2- Candidates are required to produce the following documents at the time of joining.
 - a- Medical certificate of fitness from a Government registered medical practitioner not below the rank of an assistant surgeon.
 - b- Attestation form in duplicate along with two passport size photographs duly attested by a Gazetted Officer.
 - c- Certificate of educational qualification showing the date of birth.
 - d- Two character certificates issued by Gazetted officers.
 - e- Certificate to the effect that he/she has not more than one spouse living in case of married person.
 - f- Caste certificate in original in case of ST and SC candidates.
 - g- SEBC certificate in original issued within one year in case of SEBC candidates.
 - h- Oath of allegiance.
- 3- Confirmation of appointment of SC and ST candidates is subject to verification of original caste certificate issued by the competent authority.
- 4- No TA/DA is admissible to join the post.
