**Sub: Demand Survey for preparation of HFAPoA – Regarding.**

Sir,

You must be aware that some agencies have been appointed for preparation of HFAPoA under PMAY. Currently they are conducting demand survey for all the ULBs to ascertain the number of prospective beneficiaries under PMAY scheme. The demand survey is being conducted by adopting two methods. For collecting details of beneficiaries residing in slums, door to door survey is being conducted, whereas for collecting information regarding the beneficiaries residing in non slum areas, "a camp approach" is adopted. It is learnt from the agencies that the slums have been identified in consultation with the ULBs and the ULB officials are accompanying the surveyors during the survey to ensure universal coverage. The agencies have intimated that the survey work are in the last phases. Now the ULBs have to supply the following information to the agencies for draft list of beneficiaries as per the information collected through demand survey.

- 1) List of beneficiaries sanctioned in different DPRs.
- 2) List of beneficiaries proposed for cancellation.
- 3) On-line data on PMAY projects received from CSCs and citizen centres
- 4) List of identified slums along with their boundaries.
- 5) Details of vacant spaces available in the ULBs.
- 6) Master plan of the ULBs, if any.

The ULBs will have to supply these information immediately so that the draft demand list can be prepared by the agency before 30th of June, 2018. After preparation of the demand survey list, the agencies will submit the same to the ULBs for public proclamation. The proclamation should be issued in the office notice board for wider publicity. The LUBs may publish a small advertisement in the local newspaper indicating the publication of the list in
