1. The Addl. District Magistrate-cum-Chairman, Regulated Market Committee, Bargarh invite rate quoted bid in sealed cover from the eligible authenticated Suppliers /Firms for establishment of fully electronic type (pitless kind) Weighbridge on turnkey basis with 60 M.T. capacity at Krushaka Bazar, RMC, Bargarh within two months from the finalization of the bid by signing of agreement by the bidder as per the **specification** given by the OSAM Board, Bhubaneswar vide letter no.1729 (66) dated 20.8.2019 attached with the notice and **terms & condition** as laid down vide OSAM Board, Bhubaneswar Notice No.2978 dated 19.10.2016 as given below. All bidders should submit the bid document in plain paper with proper format and with seal & signature to this office within the specified time period.

2. The details technical specification of fully electronic Weighbridge (pitless kind) of 60 M.T. capacity & the Weighbridge platform should be quality product of TATA /JINDAL / SAIL Steel with ancillary infrastructure on turnkey basis and AMC after one year of warranty should be quoted for three consecutive years.

3. The bidder should submit the rate quoted bid amount taking to the specification and follow the specification strictly at the time of supply and handed over the Weighbridge completed in all respect to the RMC within the specified time duration.

4. The bid in sealed envelope should be submitted in the office of the RMC, Bargarh before 3.00 P.M. of dated 20.11.2019 in Office Box or through Regd. Post which will reach in RMC office by 3.00 P.M. on dated 20.11.2019 . The RMC will not entertain any bid received after the time and date fixed. The bids will be opened at 11.00 A.M. on dt. 22.11.2019 .

5. The bidder, if so desire, may visit the site of installation of Weighbridge before submit the bid.

6. No advance amount will be paid to the supplier prior to completion of installation and handing over of Weighbridge.

7. The J.E./A.E. of OSAM Board, Bhubaneswar in charge of RMC, Bargarh will supervise the installation work and the bill amount will paid to the supplier after verification of technical specification by JE/ A.E.

8. At the time of submission of bid, the bidder must furnish his PAN card (Xerox) & last year I.T. return, GST certificate and latest return of GST & copy of valid license / authorization from Legal Metrology for supply of Weighbridge and his detail mail address with contact number etc.
