OFFICE ORDER

Whereas the undersigned in exercise of powers u/s 8 of the COVID Regulations, 2020, framed by the Government of Odisha and under Section 30 and 34 of the Odisha Disaster Management Act, 2005, vide this office order No.VI-70/2020-6377/Emg. Dated 16.06.2020, had declared the area in a particular circumference around the house holds of the cases of COVID-19 detected positive from the **Temporary Medical Camp (TMC) at Punjipathar High School, vill-Badipali, Block-Bijepur, Dist.- Bargarh**, with the following boundary description at "A" as a segment of Containment and the area between boundary of Containment.

Whereas active surveillance in the Containment area in the meanwhile has been saturated and the activity of intervention on our part in the Buffer Zone had reached finality,

Now, in order to restore normal life in both the areas, I, Sri Jyotiranjana Pradhan, OAS(SAG), Collector & District Magistrate, Bargarh, order annulment of the impugned order which was given effect to restrict and regulate with regard to the Containment Zone. This order of rescission shall take immediate effect.

All the arrangements made by the administration with regard to supply of essential commodities stands withdrawn. However, the regular restrictions of lockdown shall continue till further orders in the areas of the **Temporary Medical Camp (TMC) at Punjipathar High School, vill-Badipali, Block-Bijepur Dist.- Bargarh**.

BOUNDARY POINT OF ZONE OF CONTAINMENT "A"

- **Temporary Medical Camp (TMC), Punjipathar High School, Punjipathar, vill-Badipali and the area coming within a radius of 100 meters of the TMC.**


