OFFICE ORDER

Whereas the undersigned in exercise of powers u/s 8 of the COVID Regulations, 2020, framed by the Government of Odisha and under Section 30 and 34 of the Odisha Disaster Management Act, 2005, vide this office order No.VI-70/2020 5181/Emg. Dtd.23.05.2020, had declared the area in a particular circumference around the house hold of the case of COVID-19 detected positive at Master Tikira of Ward No.14 of Bargarh Municipality under Town Police Station, Bargarh, with the following boundary description at "A" as a segment of Containment and the area between boundary of Containment and an outer line delineated at "B" as Buffer Zone,

Whereas active surveillance in the Containment area in the meanwhile has been saturated and the activity of intervention on our part in the Buffer Zone had reached finality,


Now, in order to restore normal life in both the areas, I, Sri Jyotiranjana Pradhan, OAS(SAG), District Magistrate and Collector, Bargarh, order annulment of the impugned order which were given effect to restriction and regulation with regard to Containment and the activities in the Buffer Zone. This order of rescission shall take immediate effect. All the arrangements made by the administration with regard to supply of essential commodities stands withdrawn. However, the regular restrictions of lockdown shall continue till further orders in the area of Subas Nagar, W.No.14 of Bargarh Municipality.

Subash Nagar (Master Tikira) along the right side of Ram Mandir road to Master Tikira Chhak.


BOUNDARY ZONE OF BUFFER ZONE "B"






