**OFFICE ORDER**

Whereas the undersigned in exercise of powers u/s 8 of the COVID Regulations, 2020, framed by the Government of Odisha and under Section 30 and 34 of the Odisha Disaster Management Act, 2005, vide this office order No.VI-70/2020-5345/Emg. Dtd.27.05.2020, had declared the area in a particular circumference around the house hold of the case of COVID-19 detected positive at Temporary Medical Camp (TMC), Barguda High School, Barguda, Barpali Block, Bargarh district, with the following boundary description at "A" as a segment of Containment and the area between boundary of Containment and an outer line delineated at "B" as Buffer Zone,

Whereas active surveillance in the Containment area in the meanwhile has been saturated and the activity of intervention on our part in the Buffer Zone had reached finality,

Now, in order to restore normal life in both the areas, I, Sri Jyotiranjana Pradhan, OAS(SAG), Collector & District Magistrate, Bargarh, order annulment of the impugned order which were given effect to restriction and regulation with regard to Containment and the activities in the Buffer Zone. This order of rescission shall take immediate effect.


All the arrangements made by the administration with regard to supply of essential commodities stands withdrawn. However, the regular restrictions of lockdown shall continue till further orders in the area of Temporary Medical Camp (TMC), Barguda High School, Barguda, Barpali Block, Bargarh district.

**BOUNDARY POINT OF ZONE OF CONTAINMENT "A"**

- Barguda revenue village comprising of five wards, Babupali revenue village comprising of two wards, Haldipali revenue village comprising of four wards.

**BOUNDARY POINT OF BUFFER ZONE "B"**

- Barpali – Balangir State Highway on the west, main canal on the south, on the north Jatratikra, Khemesara village and on the east Bisipali and Satalma village.
