**OFFICE ORDER**

Whereas the undersigned in exercise of powers u/s 8 of the COVID Regulations, 2020, framed by the Government of Odisha and under Section 30 and 34 of the Odisha Disaster Management Act, 2005, vide this office order No.VI-70/2020-7221/Emg. Dated 01.07.2020, had declared the area in a particular circumference around the house hold of the case of COVID-19 detected positive in **Ward No.07 of NAC, Attabira, PS-Attabira, Dist.- Bargarh**, with the following boundary description at "A" as a segment of Containment and the area between boundary of Containment and an outer line delineated at "B" as Buffer Zone,

Whereas active surveillance in the Containment area in the meanwhile has been saturated and the activity of intervention on our part in the Buffer Zone had reached finality,

Now, in order to restore normal life in both the areas, I, Sri Jyotiranjana Pradhan, OAS(SAG), Collector & District Magistrate, Bargarh, order annulment of the impugned order which was given effect to restrict and to regulate with regard to Containment and the activities in the Buffer Zone. This order of rescission shall take immediate effect.

All the arrangements made by the administration with regard to supply of essential commodities stands withdrawn. However, the regular restrictions of lockdown shall continue till further orders in the area in **Ward No.07 of NAC, Attabira, PS-Attabira Dist.- Bargarh**.

**BOUNDARY POINT OF ZONE OF CONTAINMENT "A".**

- The area within a radius of 100 meters of the house of the positive case in Ward No.07 of the NAC, Attabira.

**BOUNDARY POINT OF BUFFER ZONE "B".**

- East-Primary Agricultural Co-operative Society, Attabira, West-Attabira Rice Mill Pada, North-NH-53 and South-Satnambari Gali, Attabira.
