ORDER

In furtherance of prohibitory orders under Section 144 CrPC (vide No. MA/1710-57 Dated 23/03/2020) where by curfew has been imposed in District Pathankot in the interest of public safety at large and further in view of District Controller, Food and Civil Supplies, Pathankot's letter no ins(s)/SPL-2 dated 24/03/2020, it has been felt that certain relaxations are required with respect to petrol/diesel pumps as well as LPG Distributors/Agencies taking into consideration the daily needs of the general public.

Therefore, I, Gurpreet Singh Khaira, IAS, District Magistrate, Pathankot, hereby order that the following petrol/diesel pumps will remain open till further orders:-

The owners of these units would be personally responsible that the sanitizing norms as well as social distancing protocol is strictly taken care of. Enforcement Agencies would ensure that these norms are strictly followed and also allow the movement of associated, permitted vehicles accordingly.

Any sort of misuse in any manner of this relaxation order will attract penal provisions.
