He will also mark the attendance of all the persons/teams who came present in the quarantine facility for its upkeep/functionality.5. He will ensure that the vertical flats near the quarantine facility for housing of administrative/Medical paraphernalia are fully functional and will cater to their daily essential needs. <p>He is directed to immediately visit the facility and report to DRO, Pathankot (9646754726).</p>
<p>2. Sh. P.S Parmar, AETC, Madhopur.</p>	<ol style="list-style-type: none">1. He will be Overall Manager (Isolation facility).2. He will go through all the guidelines related with the isolation facility and will tie up with the concerned officer of the Isolation Facility Management Committee (IFSC) established by the undersigned for any matter related to their department with regard to the working of the isolation facility.3. He will mark the attendance of all the persons/teams who came present in the quarantine facility for its upkeep/functionality.4. He will be responsible to cater to daily essential needs of the persons admitted in the isolation facility. All logistical support would be provided by him with regard to the facility.5. He will be single point contact for the administration with regard to the isolation facility and would maintain overall supervision of the facility. <p>He is directed to immediately visit the facility and report to Sub-Divisional Magistrate, Pathankot (9888747153)</p>
