**ORDER**

It has come to the notice of the undersigned that there is one confirmed positive case of Covid-19 in Anandpur Rara/Kulian, Pathankot. In the light of Containment Plan guidelines issued by the Ministry of Health and Family Welfare, Govt of India, Para 6.4.1 **Containment Zone and Buffer Zone** are declared as under: -

**CONTAINMENT ZONE (PLAN ANNEXED) :**


The area coloured in pink starting from west corner "A" in front of Sunny Tent House, towards corner "B" Anandpur Kulian Chowk, then from corner "B" to "C" , then corner "C" to "D" near Shashi Halwai, then corner "D" to "E" adjoining Gali, then corner "E" to "F", then corner "F" to "A" is declared as Containment Zone and Indra colony Gali No. 1 would be single exit entry point for this zone.

**BUFFER ZONE (PLAN ANNEXED):**

Area coloured in green starting from point "1" adjoining Sunny Tent house Gali to point "2" Opposite Hanuman Mandir Gali, then from point "2" to point "3" near Holi Heart School Ganda Nala, then from point "3" to point "4" Gali Papu Lamberdar Wali, then from point "4" to "5" Gaushala Road (excluding the Containment Zone) is declared as Buffer zone/area.

The Geographical limit of Containment Zone and Buffer Zone may vary depending upon the contact listing report of Rapid Response Team headed by Additional Deputy Commissioner (G), Pathankot and Epidemiologist.



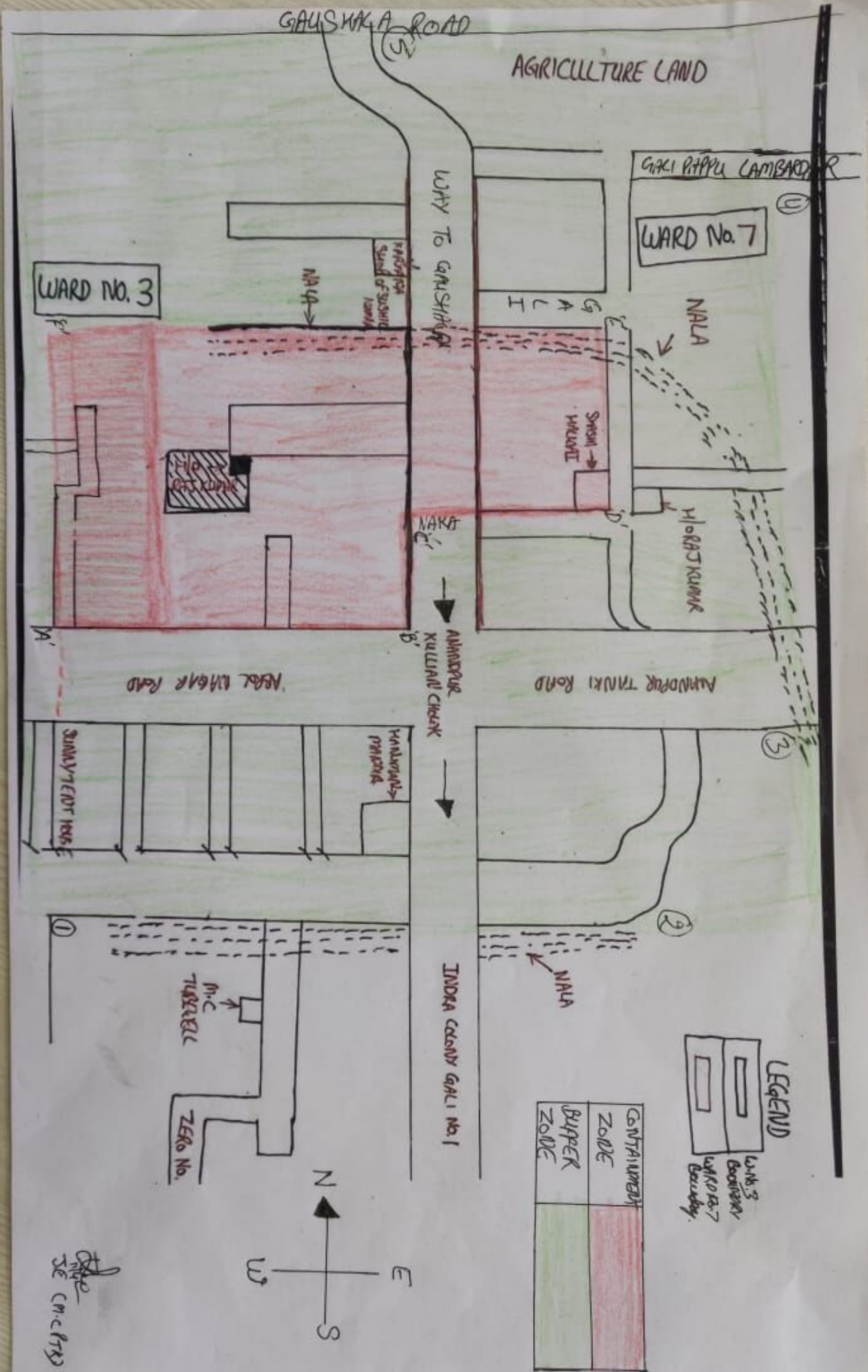

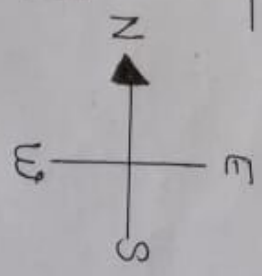
