In continuation of earlier orders by the undersigned on 28.04.2020 regarding sealing of Inter-State borders, now, these new orders are being passed consequent to letter No.IDSP/PB/2020/3737-3830 dated 28.04.2020 of the government of Punjab; Letter No.Covid-19/4HB4-2020/74 of the government of Punjab dated 29.04.2020; and order No.40-3/2020-DM-1(A) of the government of India:

1. No passengers will be allowed to enter the state of Punjab without prior agreement of the State of Punjab/ D.C of the District where the passenger is going.

All passenger vehicles coming - in shall be screened by a team of the Health Department, and, a performa shall be filled for every person entering the state (Annexure-I). This performa shall be mailed to Integrated Disease Surveillance Program.

Only in case of Medical Emergencies, shall passengers be allowed to enter the state of Punjab.

For these passengers, screening will be done on the border by a team appointed by the Civil Surgeon.

The Nodal officer will continue to use his team of teachers for enlisting all passenger vehicles coming in for medical services.

Integrated Disease Surveillance Program epidemiologist shall compile this data and send details of persons entering to the Nodal officer who will send them to respective DCs.

2. The same performa as earlier(annexed alongwith) will be filled, and will be mailed
3. The Dy.DEO (Sec), Pathankot Sh. Rajeshwar Salaria shall be the Nodal Officer-cum-Special Executive Magistrate for all that above.

The Nodal Officer will ensure that all the working staff shall have Masks/ Sanitizers/ Tea / Coffee/ Refreshments on payment basis/ need basis.

He shall also ensure that on each Desk there is a computer on which live data entry is done.

For running these Nakas, the Nodal Officer shall be provided with Rs. 50,000 for containment activities after getting approval from Deputy

Commissioner, Pathankot and Nodal Officer shall provide utilization certificate for the same upon expenditure.

4. There shall be no embargo on any vehicles carrying goods, however:-
- Trucks shall be screened medically.
 - The department of Police shall ensure that no Human Trafficking is taking place through Trucks.
