In continuation of letter no. 764/reader dated 08.06.2020

In view of lockdown due to COVID-19 crises, the following teams are established. The task of the teams is to deal with any law and order situation which may arise. Apart from this, these teams will do surveillance activity (i.e contacting the passengers in their homes, checking whether quarantined or not etc) and coordinate with Medical Rapid Response teams (RRT) associated with them. The Executive Magistrate-cum-supervisor and Assistant Executive Magistrate-cum, Supervisor shall be responsible for coordination and functioning of his team.

All the Executive Magistrate's will perform duties as under: -

- 1) They will perform all COVID-19 related duties in their respective areas and ensure **"NATIONAL DIRECTIVES FOR COVID-19 MANAGEMENT"** are implemented in letter and spirit.
- 2) Supervision of Home Quarantine persons in their respective areas and take action against those who breach home quarantine. They will ensure that each home quarantine person has uploaded COVA App in his mobile phones with bluetooth ON
- 3) Strict ground implementation of the orders issued by the office of the District Magistrate, Pathankot in their respective areas. All the order issued till date are available on Pathankot.nic.in.
- 4) They will ensure social distancing, wearing of masks, and hand sanitization is followed very strictly in their areas specially in markets, bazars and vegetable/fruit mandi's etc.

- 5) All magistrate's will carry out their magisterial duty in addition to office work of their parent department, distribution of working hours will be decided by the magistrate. In case of COVID-19 emergency, they will give priority to COVID-19 emergency duty.
- 6) All special magistrate's will work under the direct supervision of Sub Divisional Magistrate, Pathankot.
- 7) They will ensure that any person coming from other country/state is reported and home quarantine to avoid spread of COVID-19. For this purpose they should remain in touch with SHO's, GOG, SMO's, Sarpanch's, MC's of their respective areas.
- 7) They will submit their daily reports in the proforma given on whatsapp group daily before 07:00 PM. Any emergency must be reported immediately to the Additional District Magistrate, Pathankot and Sub Divisional Magistrate, Pathankot.

National Directives for COVID-19 Management

1. **Face coverings:** Wearing of face cover is compulsory in public places; in workplaces; and during transport.
2. **Social distancing:** Individuals must maintain a minimum distance of 6 feet (2 gaz ki doori) in public places.
Shops will ensure physical distancing among customers and will not allow more than 5 persons at one time.
3. **Gatherings:** Large public gatherings/ congregations continue to remain prohibited.
Marriage related gatherings : Number of guests not to exceed 50.
Funeral/ last rites related gatherings : Number of persons not to exceed 20.
4. **Spitting in public places** will be punishable with fine, as may be prescribed by the State/ UT local authority in accordance with its laws, rules or regulations.
5. **Consumption of liquor, paan, gutka, tobacco etc.** in public places is prohibited.

Additional directives for Work Places

6. **Work from home (WfH):** As far as possible the practice of WfH should be followed.
7. **Staggering of work/ business hours** will be followed in offices, work places, shops, markets and industrial & commercial establishments.
8. **Screening & hygiene:** Provision for thermal scanning, hand wash and sanitizer will be made at all entry and exit points and common areas.
9. **Frequent sanitization** of entire workplace, common facilities and all points which come into human contact e.g. door handles etc., will be ensured, including between shifts.
10. **Social distancing:** All persons in charge of work places will ensure adequate distance between workers, adequate gaps between shifts, staggering the lunch breaks of staff, etc.
