Order:-

Whereas Lockdown Unlock-3 under section 144 of Cr.Pc was imposed by undersigned to prevent and contain spread of corona virus COVID-19 disease vide order No. 723-40 Dated 1.08.2020.

Whereas now Special Chief Secretary, Home, Government of Punjab, Department of Home Affairs and Justice has issued guidelines for " Additional restrictions in all the cities of Punjab during Unlock-3 "vide their letter No.Ss/CASH/2020/592 Dated: Chandigarh, the 17 of August, 2020 in continuation to their previous orders.

Whereas now keeping in view the guidelines Issued by Special Chief Secretary Home, Government of Punjab by aforesaid letter, I Sanyam Aggarwal, IAS, hereby issues the following orders in territorial Jurisdiction of District Pathankot under section 144 of Cr.PC. In partial modification to orders issued vide No. 723-40 Dated: 1.08.2020.

Additional restrictions in all the cities of Punjab during Unlock-3.

On account of sudden rise in COVID-19 cases in urban areas, additional restrictions are imposed within municipal limits of all the cities of the District Pathankot (i.e within areas of Municipal Corporation Pathankot , Municipal Council Sujampur, Notified area Committee of Narot Jaimal Singh) w.e.f. 18th of August 2020 till further orders :

1. Night curfew (09.00 pm to 05.00 am):

Movement of individuals for all the non-essential activities shall remain prohibited between 9.00 pm to 5.00 am within municipal limits of all the cities of District Pathankot.

However, essential activities including operation of multiple shifts, movement of persons and goods on National and State Highways and unloading of cargo and travel of persons to their destination after disembarking from buses, trains and aeroplanes will be permitted.

Similarly, all industries running into 2-3 shifts will also remain open.

2. Restrictions on timing:

3. Stay Safe at Home:

- People are requested to avoid unnecessary travel on Saturdays and Sundays
- Shops (other than those dealing in essential commodities) and shopping malls throughout the District are to remain closed on Sundays as per guidelines dated 31.07.2020 till further orders

Strict compliance of above orders shall be ensured

This order shall come into force from 18.08.2020
