

## Office of the District Magistrate, Pathankot

### Order:-

Whereas Lockdown Unlock-3 under section 144 of Cr.Pc was imposed by undersigned to prevent and contain spread of corona virus COVID-19 disease vide order No. 723-40 Dated 21.08.2020.

Whereas now Special Chief Secretary, Home, Government of Punjab, Department of Home Affairs and Justice has issued guidelines for " Additional restrictions in all the cities of Punjab during Unlock-3 "vide their letter No.Ss/CASH/2020/595 Dated: Chandigarh, the 21<sup>st</sup>. of August, 2020 in continuation to their previous orders.

Whereas now keeping in view the guidelines Issued by Special Chief Secretary Home, Government of Punjab by aforesaid letter, I Sanyam Aggarwal, IAS, hereby issues the following orders in territorial Jurisdiction of District Pathankot under section 144 of Cr.PC. In partial modification to orders issued vide No. 723-40 Dated: 21.08.2020.

**Additional restrictions in urban areas of Distt. Pathankot be implemented from 22.08.2020 to 31.08.2020.**

#### 1. Curfew (All cities) :

- **Weekend Curfew:** Total Curfew on Saturdays and Sundays in all the municipal towns of Pathankot upto 31.08.2020.
- **Night curfew :** Movement of individuals for all the non-essential activities shall remain prohibited between 7:00 pm to 5:00 am within all municipal limits of district Pahtankot throughout the week.

However, essential activities and services, movement of persons and goods on National and State Highways, inter state & intra state movement of persons and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and aeroplanes will be permitted. Essential services include services



related to health , agricultural and related activities, dairying and fishery activities, banks, ATMs, stock markets, insurance companies, on-line teaching, public utilities, public transport industry in multiple-shifts, construction industry, offices both private and government, media both visual & print etc.

Movement of persons and students in the connection with all kinds of examinations, admission/entrance tests conducted by Universities, Boards, Public Service Commissions and other institutions shall be permitted.

2. **Shops, Restaurants, Hotels, Liquor Vends etc. (all cities) :**

3. **Vehicles :**

- Only 3 persons including driver to be allowed in a 4-wheeler vehicle.
- All buses and public transport vehicles to allow sitting for 50 % capacity with no person standing.

4. **Ban on gatherings:**

All social, political, religious gathering, protests and demonstrations are banned in the district. However, gatherings relating to marriage and funerals are allowed only for 30 persons and 20 persons respectively.



5. **Government and private offices:**

Government and private offices shall operate with 50% staff strength till the end of the month i.e. not more than 50% of employees would be permitted on a particular day. The Heads of Offices would restrict public visitors in Government offices and encourage use of on-line Punjab Grievance Redressal System (PGRS) and other on-line tools so as to minimise person to person contact in offices.

6. Activities not mentioned in these guidelines from para 1 to 5 would be governed by order dated 01.08.2020.

Strict compliance of above orders shall be ensured

This order shall come into force from 22.08.2020
