Whereas Lockdown Unlock-3/ revised 1 under section 144 of Cr.PC was imposed by undersigned to prevent and contain spread of Corona Virus COVID-19 disease vide order No. MA/299-339 dated : 21.08.2020.

Whereas Secretary, home Affairs and Justice, Government of Punjab has issued guidelines vide letter No. SS/ACSH/2020/597 dated 25.08.2020 for Clarifications regarding additional restrictions in urban areas of Punjab to be implemented from 22.08.2020 to 31.08.2020.

Whereas now keeping in view the above said guidelines issued by Secretary home, Government of Punjab by aforesaid letter, *I Sanyam Aggarwal, IAS, District Magistrate, Pathankot* hereby issues the following orders in territorial jurisdiction of District Pathankot is as under :-

In this context, the following clarifications are issued:

- (i) Sports complex and stadiums will be open but without any spectators.
- (ii) Public parks will be open without any gathering.
- (iii) Gymnasiums can open with strict implementation of SOPs issued by the Ministry of Health & Family Welfare (MoHFW), Government of India (Gol).
- (iv) E-Commerce, Courier & Postal Services are allowed on all 7 days.

These order shall come into force from 25.08.2020
