Keeping in view the larger public interest in the scenario of emerging threat of Pandemic Covid-19, In continuation to earlier order No. 9023-44/MA dated 14-10-2020 and keeping in view of latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no PA/ACSH/2020/23 dated 31.10.2020 (Copy enclosed) I, Sanyam Aggarwal, IAS, District Magistrate, Pathankot in exercise of powers conferred upon me under section-144 of CrPC 1973 and National Disaster Management Act, 2005 order for reopening of more activities outside Containment Zones, to be implemented from 01.11.2020 upto 30.11.2020 in District Pathankot: -

1. The order regarding reopening of activities, issued by this office vide letter No. 9023-44/MA Dated 14.10.2020 are extended upto to 30.11.2020. In addition, the following activities are also permitted w. e. f. 01.11.2020 to 30.11.2020

- a) Cinemas/theatres/ multiplexes with upto 50% capacity of their seating capacity in areas outside Containment Zones as per SOP issued by the Ministry of Information & Broadcasting (MoI&B), Government of India.
- b) Entertainment parks and similar places in areas outside Containment Zones as per SOP issued by the Ministry of Health & Family Welfare (MoH&FW), Government of India.
