Keeping in view the larger public interest in the scenario of emerging threat of Pandemic Covid-19, In continuation to earlier order No. 9023-44/MA dated 14-10-2020 and keeping in view of latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no PA/ACSH/2020/38 dated 4.11.2020(Copy enclosed)I, Sanyam Aggarwal, IAS, District Magistrate, Pathankot in exercise of powers conferred upon me under section-144 of CrPC 1973 and National Disaster Management Act, 2005 order for reopening of Higher Education Institution and Colleges in District Pathankot.

The order regarding reopening of activities , issued by this office vide letter No. 9023-44/MA Dated 14.10.2020 are extended upto to 30.11.2020. In addition, the following activities are also permitted w.e.f. 01.11.2020 to 30.11.2020

It has now been decided to reopen all the Higher Education,Medical Education & Research and Technical Education Institutions including all Universities and Colleges in areas outside Containment Zones in the Distt. Pathankot from 16.11.2020. However, classes for final year students of Universities & Colleges under the Medical Education & Research Department shall commence for 9<sup>th</sup>.November,2020. All these institutions shall strictly observe the SOP to be framed by their respective administrative Department of Health & Family Welfare ,Government of Punjab and the ministry concerned of the Central Government.
