**ORDER:**

The corona virus has spread to almost every country in the world. As a result, Corona Virus has been declared an epidemic by the World Health Organization (WHO). While, now the corona virus effected cases have been found in district Pathankot.

Keeping in view the larger public interest in the scenario of emerging threat of Pandemic Covid-19, In continuation to earlier order No.MA/MC-1/9874-9900 dated 05.11.2020 on re-opening of more activities in areas outside Containment Zones in Punjab to be implemented after 05.11.2020 were circulated.

But now view of latest guidelines received from the Government of Punjab, Department of Home Arrairs & Justice, Chandigarh vide No.7/56/2020/2H4/4572 dated 26<sup>th</sup> Nov. 2020 (Copy Attached) I, Sanyam Aggarwal IAS, District Magistrate, Pathankot in Exercise of powers conferred upon me under section-144 of CrPC 1973 and National Disaster Management Act, 2005 order for additional restrictions are hereby imposed from 1<sup>st</sup> December 2020 as under:-

**(i) Night Curfew from 10 PM to 5 AM in all cities and towns:**

Movement of individuals for all the non-essential activities shall remain prohibited between 10:00 pm to 5:00 am within municipal limits of Jurisdiction of District Pathankot.

However, essential activities including operation of multiple shifts in industry, offices both Government and private etc. movement of persons and goods on National and State Highways and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains, and aeroplanes will be permitted.

**(ii) Restrictions on timing of Hotels, Restaurants, Marriage Palaces etc:**

All the Hotels and other Hospitality Units, Restaurants and marriage Palaces including restraurants/hotels within shopping malls/multiplexes shall shut down by 9:30 pm.

**(iii) Social distancing, wearing of masks, sanitization etc:**

Social distancing i.e. minimum 6 feet distance (do gaz ki duri) for all the activities shall always be maintained. Accordingly, if any permitted activity leads to crowding and congestion, then necessary steps in terms of staggering, rotation etc. be taken and it be ensured that principles of social distancing are not compromised.

Wearing of masks, not spitting and frequent use of hand-wash/sanitizers by all persons in public places including work places etc. and also regular sanitizing of all the public/work places by the authorities concerned will be mandatory and must be strictly observed and enforced.

The Department of Health & Family Welfare, Government of Punjab has, vide Notification No 9/NHM/Pb /20/2303 dated the 30<sup>th</sup> July 2020 (*copy attached for ready reference*), imposed various penalties in case of violation of Government instructions and guidelines regarding prevention & control of COVID-19 pandemic. Penalty for not wearing of masks and spitting in public places is hereby enhanced from Rs.500/- to Rs1000/- for each violation.
