ORDER:

Keeping in view that larger public interest in the scenario of emerging threat of Pandemic Covid-19, In continuation to earlier order No.MA/MC-1/10875-10900 dated 27.11.2020 and keeping in view of latest guidelines received from the Government of Punjab, Department of Home Affairs and Justice, Chandigarh vide no 7/56/2020/2H4/4856 Dated 14.12.2020 (Copy Enclosed) I, Sanyam Aggarwal IAS, District Magistrate, Pathankot in Exercise of powers conferred upon me under section-144 of CrPC 1973 and National Disaster Management Act, 2005 order for additional restrictions are hereby imposed from 15th December 2020 as under:-

2. Considering COVID – 19 situation, it has been decided to further continue all the restrictions as imposed vide the abovementioned circular till 31st December 2020 including (i) Night Curfew (from 10 pm to 5 am) in all cities and towns of District Pathankot. (ii) Timings of closure (by 9:30 pm) of Hotels, Restaurants, Marriage Palaces/Resorts etc. and impose an additional restriction till 31st December 2020 as under:-

"Social gatherings shall be restricted to maximum of 100 persons for any indoor event and 250 persons in outdoor gatherings.

It shall be enforced w.e.f 15th December 2020 and shall continue to be in force till 31st December, 2020."
