ORDER

In compliance of the letter no. PS/ACS Home/ Spl-II dated 30-03-2020 for the effective implementation of the directions issued by Hon'ble Supreme Court of India on 23-03-2020 is Suo Motu Writ Petition (Civil) No. 1/2020 regarding COVID-19 outbreak situation, due to the lockdown orders imposed all over the state of Haryana, it has been directed to facilitate the process of grant of parole at the prisons itself,

Therefore, I, Dr. Aditya Dahiya, IAS, District Magistrate, Jind by virtue of the powers conferred upon me under section 22(1) and 23(2) of the Code of Criminal Procedure, 1973, delegate and authorize the **Executive Magistrate** (duly empowered vide no. K.C. / Coord-I/1341-43 dated 27-03-2020 of the Ld. Divisional Commissioner, Hisar) for **approval and Execution of Surety Bonds for Grant of Parole**, and appoint the **Sh.
