Order

In order to break the transmission of Corona Virus (COVID-19), which has been declared a pandemic, the undersigned using the powers and provision of The Disaster Management Act, 2005 has also issued prohibitory orders under section 144 of the Code of Criminal Procedure, 1973, which restrict movement of any person from out of his house from 23-03-2020 onwards.

In pursuance of Government of Punjab, Department of Home Affairs & Justice letter no. SS/ACSH/2020/354 dt. 03-05-2020 and Letter no. SS/ACSH/2020/355 dt. 04-05-2020, MHA Guidelines No. 40-3/2020-DM-I(A) dated 01/05/2020, the shops and banks were allowed to open between 09:00 AM to 01:00 PM vide this office **order No.MA/119954/254 dated. 05-05-2020.**

Now, in pursuance of Government of Punjab, Department of Home Affairs & Justice letter no. SS/ACSH/2020/361 dt. 06-05-2020, Letter no. SS/ACSH/2020/354 dt. 03-05-2020, Letter no. SS/ACSH/2020/355 dt. 04-05-2020 and MHA Guidelines No. 40-3/2020-DM-I(A) dated 01/05/2020 the shops are allowed to open between **07:00 AM to 03:00 PM.**

Whereas as the schedule depicted in the earlier **order No.MA/119954/254 dated. 05-05-2020** shall be same for shops/sweet shops/grocery shops/chemist/laboratories, however only timing will be changed to **07:00 AM to 03:00 PM**

Whereas, **Banks** shall be continued to open for public dealing work only from **09.00AM to 01.00 PM** but allowed to carry out their non public dealing office work as per their requirement.
All shops will be closed on Sunday.

Note:- A complete ban on moving of 4 wheelers & 2 wheelers during 07:00 AM to 03:00 PM in Barnala city except vehicles of Govt. officials going on Govt. duty/work place and vehicles used for banks and in medical emergency as mentioned in earlier order dated 28-03-2020. The persons who are entering into Barnala city from other places(outside of Barnala city) during 07:00 AM to 03:00 PM can park their vehicles on khudi road/bajakhana road/anaz mandi/court chowk (under fly over)/pakka college road/ dhanaula road/new cinema parking/mata gulab kaur chowk and 22 acre market. A legal action can be taken against violators.
