CURFEW ORDER

Due to the spread of epidemic disease of CoronaVirus (COVID-19) in many countries and many states of India and its likely impact on the residents of District Barnala, which can endanger human life and affect the health of general public in a serious manner; and

Whereas I am fully satisfied that there are sufficient grounds for proceeding under section 144 of the Code of Criminal Procedure, 1973 and immediate preventive and speedy remedy is desirable;

Now, therefore, I, **Tej Partap Singh Phoolka, IAS, District Magistrate, Barnala** by virtue of powers vested in me under section 144 of Code of Criminal Procedure, 1973, here by Impose Curfew from **04 May 2020 to till 17 May, 2020** and direct that no member of the public shall remain out of doors on any street, road, public place within the limits of the whole of District Barnala. This order is in continuation of curfew Order No. MA/119954/ 168 Dated 23-3-2020 and Order No. MA/119954/222 Dated 15-04-2020.

This order shall take effect at once.


In view of the urgency of the matter arising out of the above situation, this order is being passed ex-parte and is addressed to the general public.

This order shall however, not apply to:-

(1) Police Personnel, (2) Military and Para Military Personnel in uniform, (3) Doctors, Nurses, Para-medical staff on emergency services (4) Govt. functionaries on duty on production of Identity Card (5) Members of Home Guards on duty (6) Persons to whom a curfew passes/permits are already issued (would also be valid during the extended curfew period) by the District Magistrate Barnala/Additional District Magistrate Barnala/Sub Divisional Magistrate/Executive Magistrate or Any other Govt. Officer on duty Authorized by me in this behalf.

Various orders issued under my hand and seal from 23-3-2020 shall continue to operate regarding various essential services to be provided to the residents of District Barnala.
