In exercise of the power conferred by section 14 and 17 of the West Bengal Panchayat Election Act, 2003 (West Ben. Act XXI of 2003), read with rules 24 and 25 of the West Bengal Panchayat Election Rules, 2006, I, the District Panchayat Election Officer and District Magistrate of the district of Darjeeling as the prescribed authority appointed by the State Government in the Department of Panchayat and Rural Development under notification No. 5316/PN/O/1/1A-3/2010 DATED 01.07.2010 for the purpose of rule 24 and 25 of the said rules, determine after after previous publication of the draft of this order as required under the said rules, for the Grams specified in column (1) of the Schedule below, the number of members to be elected to the Panchayat Samiti specified in the corresponding entries in column (2), to divide the area of the Grams into constituencies specified in the corresponding entries in columns (3) & (4), constituency or constituencies reserved for the Scheduled Castes or the Scheduled Tribes or the Backward Classes persons specified in the corresponding entries in column (5), and constituency or constituencies reserved for women specified in the corresponding entries in column (6) of the said Schedule.
