e - Quotations are invited on behalf of the District Magistrate ,Darjeeling for Purchasing of Ordinary Warm Cloths for Distribution through MLAs of Hill areas for Kurseong and Darjeeling from the reputed firms/ agencies. The intending tenderers may visit Website – www.darjeeling.gov.in for the tender notice & other details. But submission of bid will be through the web site www.wbtenders.gov.in only.

- For e-tendering, intending tenderer may download the tender document from the said website directly with the help of Digital Signature Certificate. Necessary Earnest money(where required) shall be deposited by the intending tenderers by way of Online/ NEFT/RTGS through ICICI Payment Gateway in favour of the District Magistrate, Darjeeling,
- Before submission of the Bid, the intending tenderers may verify the sample preserved at the Disaster Management Section of the Collectorate during office hour of a working day. Their supply must be in conformity with the sample in terms of quality.
- Properly Indexed & self-attested documents & duly digitally signed of both the Technical Bid and the Financial Bid should be concurrently submitted in the Website mentioned above as per time schedule given below.
- Eligibility criteria for participation in tender :**
 - The prospective tenderer, as a primary agency, should be a reputed agency and should have the duly authenticated credentials of supply of similar nature of materials amounting to at least Rs. 10 Lakh within last three financial years.
 - Technical Bid Documents should be accompanied with copies of tenderer's Pan Card, valid Trade Registration as authenticated by the appropriate authority, Professionals Tax Receipt/Challan for the current financial year, Income Tax Returns Challan for the **financial year, 2017-18, 2018-19, 2019-20**, GST Registration certificate
 - The Government approved supplying Organization viz Manjusha, Bangasree. Refugee Relief & Rehabilitation Directorate, Confed & Refugee Handicrafts are exempted from furnishing credentials required for the purpose.
 - Neither any Mobilization Advance nor any Secured Advance will be allowed.
 - Bids shall remain valid for a period of 60 (Sixty) days from the date of opening of Financial Bid.**
 - There shall be no provision of Arbitration.
- Rate should be quoted in the BOQ in every item , if any item is found incomplete then that portion will be counted as 0(Zero) and the bidder should provide those item in free of cost.**

6. Financial bids of those tenderers who qualify in technical bid will only be opened. Dates, if changed, due to unavoidable circumstances, will be published in the said websites and the office notice board only without any individual intimation.
7. No cost of Bidding shall be reimbursable by the Office of the District Magistrate, Darjeeling. Authority may accept or reject any tender without assigning any reason, whatsoever, and is not liable for any cost that might have been incurred by a Bidder.
8. The District Magistrate, Darjeeling reserves the right to cancel the N.I.Q due to unavoidable circumstances and no claim in this respect will be entertained
9. The Tender Inviting Authority may verify the original credential & other original documents of the lowest tender, if found necessary, before issuance of the work order and the work order will not be issued in favor of the tenderer if it is found on verification that such document submitted by him is either manufactured or fabricated, etc.

Criteria of conformity:

- a) Garment cloths should not be union fabric i.e both warp and weft yarns must be blend of Polyester and wool fibres.
- b) All the test specimen must meet all the specified value.
