

OFFICE OF THE DISTRICT MAGISTRATE, KURUKSHETRA.

ORDER

Whereas, the District Kurukshetra has been notified LOCKDOWN by the Haryana Government vide Endst No. 284-93/COVID/2020 Dated, 23-3-2020 in view of the apprehension of the community transmission of the nCOVID-19 epidemic, thus, it is expedient that precautionary measures should be taken to prevent & contain the spread of nCOVID-19 for human health and safety of general public in District Kurukshetra.

And whereas, the undersigned is empowered under Epidemic Disease Act, 1897 to issue directions regarding containment measures to prevent and contain the spread of nCOVID-19 disease, I, **Dhirendra Khadgata, IAS, District Magistrate, Kurukshetra** do, hereby, regulate the operations of following activities in District Kurukshetra till 14th April 2020 :-

1. No public transport service including operation of taxis, auto-rickshaws will be permitted. The exception will include transport of all kinds to and from hospitals, airports, railway station, bus terminals/bus stands and for the purpose essential services after sanitize their vehicle.
2. All shops, commercial establishments, offices and factories, workshops, godowns etc. shall close their operations excepts for essential services mentioned below.
3. All foreign returnees are directed to remain under strict home quarantine for a period as decided by local Health Authorities. All the citizens/officers are advised to report to the civil surgeon, Kurukshetra if they have returned from the Foreign tours from 01.01.2020 to till date. The public in general is also advised to provide such information if any person return from Foreign during this period.
4. Peoples are required to stay at home come out only for basic services while strictly following social distancing guidelines.
5. Suspension of the operations of all Gymnasium, Swimming Pools and Spas.
6. Suspension of the operations of all Night Clubs/Discos, Lounges & Bars, Ahatas, Cinema Halls, Theatres, Banquets Hall, Multiplexes, Concerts/ Performances, Family Entertainment Centre/Fun Fair/Amusement Park gathering shall be strictly regulated to prevent any crowd.
7. Any gathering such as Social/Cultural/Political/Academic/Sports/Seminar /Conferences and Family Mass gathering (including marriages and functions) are restricted.
8. Irrespective of faith/denomination all Religious gatherings shall be strictly regulated to prevent any crowd.
9. Closure of Schools, Colleges, Universities, Coaching/Institutes/Tuition centers/ Hotel Bars.
10. Suspension of operations of Dine-In Services in all the Restaurants, Cafes, Eateries and Dhabas **except** take away, drive thru, home delivery.
11. All meat shops/stalls to be closed till further orders.
12. The public dealing at government offices should be minimized while not impacting time-bound & essential services.
13. Owner of Saloons, Beauty Parlours, Grooming Centers are directed to completely suspend their activities.
14. Construction sites & their labour housing shall be regularly decontaminated & screened for any symptoms, if this is not done then the site shall be liable for closure.
15. Restricting the vehicular movement in the areas of Isolation Centers, Quarantine Centers as declared by Civil Surgeon, Kurukshetra.
16. All Private, Corporate establishments & Factories to be completely shutdown other than the permitted list. The operations of all Weekly Bazaars, Shopping Malls, Shopping Centers/Shopping Complex, Local Markets to be ceased.

However, the following establishments providing essential services shall be allowed to operate but with due caution for strict social distancing/ decontamination.

- a) Government offices/establishments as per the instructions of Chief Secretary Office.
 - b) Rail (Rail services already suspend till 14th April, 2020) and Air. Local administration will regulate eateries in these premises.
 - c) Electricity, Water, Sewerage and Municipal Services.
 - d) Bank/ATM.
 - e) Print, Electronic and Social Media
 - f) Telecom & Internet Services including IT&ITeS.
 - g) Postal Services
 - h) Supply chain and related transportation.
 - i) Manufacturing units engaged in production of essential commodities, agriculture commodities & agriculture inputs, food items and wholesalers, retailers of such items.
 - j) E-commerce (delivery) of all essential goods including food, pharmaceutical and medical equipment.
 - k) Food, Groceries, Milk, Bread, Fruit, Vegetable, Atta etc. and their transportation related activities and warehousing.
 - l) Take away/home delivery restaurants/eateries.
 - m) Hospitals, chemist shops, optical stores, Pharmaceuticals, manufacturing units including mask and sanitization material manufacturing units and their transportation related activities.
 - n) Petrol pumps, LPG gas, Oil agencies, their godown and their transportation related activities.
 - o) Production and Manufacturing Units which require continuous process may continue subject to such restrictions (including transportation) as imposed by the district administration and after obtaining permission from the Deputy Commissioner.
- 17 Private establishments that support the above services or are linked to the efforts for containment of nCOVID-19 will remain open.
 - 18 Transport plan and any amendments, if required, shall be prepared by the Addl. Deputy Commissioner-and-Secretary, Regional Transport Authority, Kurukshetra. The goods vehicles carrying the essential items shall be allowed to ply during the shutdown period. The drivers and the work force involved in loading/un-loading the materials, shall take all precautionary measures. The Secretary, R.T.A. will ensure to ply the vehicles and safety measures and sanitisation of carrying goods essential commodities. She shall also issue the permit for carrying essential commodities from other states.
 - 19 The RWAs shall take necessary measures for social distancing and for maintaining essential services. If any violation found, same shall be informed to police control room by President/Secretary of RWAs. in case, such information not given to the police the concerned President/Secretary of RWAs will be responsible.
 - 20 DFSC & DMEO, Kurukshetra shall ensure that there is strict check in any hoarding/rise of retail price.
 - 21 Factories/Production sites/Commercial entities shall be allowed to have security & fire fighting personnel present.
 - 22 If any foreigners stay in any Hotels/Stay Homes, it will be responsibility of management to inform the district authorities at the earliest preferably within two hours, failing which their establishment will be closed till further directions
 - 23 If there is a doubt about as to whether a service or establishment is essential or not, the District Magistrate, shall give a final decision on the same.
 - 24 In order to availability of essential commodities and rate control thereof the Sub Divisional Officer (C) of respective Sub Division and District Food & Supply Controller shall take all preventive measures and ensure availability of essential commodities and control of rates thereof. They shall get assistance of Revenue, Police, Panchayat, Lambardars as well as staff of Marketing Board for this purpose.
 - 25 Circulation of newspapers in the area through hawkers shall be upto 7AM only. It is necessary for the agencies of newspaper running in the district to ensure sanitization code

before their circulation amongst the public in general. Further, the pamphlets attracting any type of advertisement shall not be allowed.

- 26 The Executive Officer, Municipal Council, Thanesar/Secy Municipal Committee, Shahabad, Pehowa, Ladwa, Ismailabad, Secretary, Market Committee, Thanesar, Pipli, Ladwa, Babain, Shahabad, Ismailabad, Pehowa, D.D.P.O., Kurukshetra and BD&PO, Thanesar, Pipli, Ladwa, Babain, Shahabad, Ismailabad, Pehowa shall ensure the spray of Sodium Hydrochloride in their respective areas.

Superintendent of Police to direct all SHO's for strict implementation of the restrictions. However, the nCOVID-19 is a disaster for the country. Hence, the public in general are advised to inform the concerned SHO if any seen indulge to open shops to sale the items other than essential commodities.

Failure to obey these orders shall be penalized under section 188 of I.P.C. with punishment of severe fine and imprisonment.

In view of requirement of the situation which has become emergent, this order, is being passed ex-parte. It shall be published for the information of public through the press and publicity van of public relations department and by affixing copy at notice board of District Courts, Zila Parishad, Sub Divisions, Tehsils, Municipal Council, Municipal Committees, Panchayat Samities, Police Stations and Public Places.
